Qualification : The applicant should be a graduate of Electrical / Mechanical Engineering discipline – with good academic record from a recognized University / Institution of repute. Preference will be given to candidates belonging to Indian Railway Service of Electrical Engineers (IRSEE) or Indian Railway Service of Mechanical Engineers (IRSME). In exceptional cases, the candidates having Diploma in Electrical / Mechanical Engineering with maintenance experience of 12 years or above may be considered.

Experience : Minimum 7 years post qualification experience in Maintenance / Testing & Commissioning of Rolling Stock in Railways / Metro Railways. The candidates having good & proven experience of working with / for Original Equipment Manufacturers (OEMs) for Maintenance / Testing & Commissioning of Rolling Stock of Railways / Metro Railway viz. Railway Production Units, BEML, Siemens, Bombardier, Alstom, etc. will also be considered. The certificate of working for OEMs should clearly indicate the nature of experience covering Maintenance / Testing & Commissioning. The experience in maintenance will be preferred. The applications submitted with vague experience certificates will be summarily rejected. Out of 7-year experience minimum 2-years' experience should be on immediate one level lower post in the serving organization.

Maximum Age Limit : 45 years as on 1.8.2020. Age relaxation can be considered in case of deserving candidates.
